In accordance with the Companies Act, 2013 and the Rules framed there under and the Schedule VII under Companies Act 2013, CSR activities in focus include:

**(E) CONTRIBUTION TO FUNDS:**

**(F) RURAL DEVELOPMENT PROJECTS:**
